# O2 stage. Summary by the project manager.

The O2 stage, "Methodology and Processes for online-, blended- and distance- learning and teaching along the learning lifecycle, both under normal- and Covid-19 and the like- situation, based on digital technology, business continuity best practice and standards.", comprises

#### Stage O2 covered 12 tasks.

This Intellectual output development is led by CARDET and comprises the next main tasks: **O2-A1** Definition of the online-, blended- and distance- learning and teaching lifecycle. ([A] CARDET, [C] partners)

**O2-A2** For each stage of the lifecycle – definition of the typical activities and challenges related to the online-, blended- and distance- forms of learning and teaching. ([A] CARDET, [C] partners)

**O2-A3** Considering O2-A1 and O2-A2, design of a core process for online-, blended- and distance- learning and teaching under normal situation ([A] CARDET, [R] SBC, [C] partners)

**O2-A4** Business Impact Analysis (BIA) on the core process (as per O2-A3) to:

- Assess the impact during the disruptions of key activities of this process, caused by Covid-19 or similar circumstances
- Define priority deadlines to recover these activities to minimal acceptable levels, considering the time after which their recovery is unacceptable
- Identify the dependencies and necessary resources for these activities ([A] CARDET, [R] SBC, [C] partners)

### **O2-A5** Risk assessment to:

- Identify the risks and the related scenarios of disruption caused by Covid-19 or similar circumstances
- Assess which disruptions require treatment
- Define treatment according to the online-, blended- and distance- learning and teaching aims.

**O2-A6** Definition of education continuity strategy based on the digital platform (O1) and digital learning content (O3). ([A] CARDET, [C] partners)

**O2-A7** Development of teaching/learning continuity procedures supported by the digital platform (O1) and digital learning content (O3). These procedures shall provide "digital

response" for any scenario of disruption process, caused by Covid-19 or similar circumstances and identified by the Business Impact Assessment. ([A] CARDET, [C] partners)

**O2-A8** Development of specific procedures for testing, examination, assessment, validation of competences when the learning is via online-, blended- and distance learning environment. ([A] CARDET, [C] partners)

**O2-A11** Prepare end-stage report and do end-stage activities as required by the Erasmus program and the contract ([A] CARDET, [C] partners)

O2-A12 Publish the stage results at the project web-site after approval. ([A] CARDET, [R] SBC, [I] partners)

Quality assurance of O2 stage output was conducted. This task was led by one of the partners ACEEU GmbH. The rest of partners participated in the assessment. No new risks were identified.
